_____ Hickory Tree Veterinary Hospital agrees to exercise due diligence and reasonable care and to keep the premises sanitary and properly enclosed. All pets are handled or cared for by Hickory Tree Veterinary Hospital staff without liability on Hickory Tree Veterinary Hospital's part for loss or damage from disease, fire, escape, injury or harm to persons, other pet(s) or property by said pet, or from other unavoidable causes, due diligence and care having been exercised.

_____ Owner is aware of the risks involved with their pet interacting with other pets in a group setting. These include, but are not limited to getting dirty, scrapes, cuts, bites, and viral and bacterial infections. During inclement weather your pet may get dirty while playing outside and/or outside playtime may be restricted.

_____ I further understand and agree that in admitting my dog(s) to the Daycare, Hickory Tree Veterinary Hospital Daycare has relied on my representation that my dog(s) is in good health and has not harmed or shown aggressive or threatening behavior towards any other dog or human.

_____ Should any pet become ill or seem to be in need of medical consideration, Hickory Tree Veterinary Hospital reserves the right to administer aid and/or to use available veterinarian. Any expenses so incurred shall be paid by the Owner of said pet in addition to the fees incurred for services provided at or by Hickory Tree Veterinary Hospital.

_____ Owner agrees to pay the rate for services in effect on the date their pet is checked into Hickory Tree Veterinary Hospital. Prices are subject to change at any time, without notice.

_____ **Pet must be current on all vaccinations: Rabies, DAPP, Bordetella (every 6 months), Canine Influenza, current negative Fecal (every 6 months), and mandatory monthly scheduled prevention program for flea/ticks/lice and heartworms (veterinarian approved) Have been Spayed or Neutered if over the age of 6 months, if not neutered pet will become a Day Boarder and not allowed in group activities. Any female dog in heat will have to remain home until cycle is over, if not spayed after heat that pet will become Day Boarder and not allowed in group activities. Hickory Tree Veterinary Hospital reserves the right to refuse service to any dog not current on these protocols.**

_____ *****Pets that are on raw diets are welcome to Day Board (which incurs a different fee), but will not be able to participate in group activities.**

(The AVMA discourages the feeding to cats and dogs of any animal-source protein that has not first been subjected to a process to eliminate pathogens because of the risk of illness to cats and dogs as well as humans. Cooking or pasteurization through the application of heat until the protein reaches an internal temperature adequate to destroy pathogenic organisms has been the traditional method used to eliminate pathogens in animal-source protein, although the AVMA recognizes that newer technologies and other methods such as irradiation are constantly being developed and implemented.)

_____ I further understand that the Bordetella vaccine does not 100% guarantee against contracting Bordetella, as there are several different strains of the virus that causes kennel cough and/or coughing, runny nasal passage, etc.

_____ Owner agrees that pet will be picked up by Owner or a pre-approved Owner's agent by **5:25 pm**; after 5:30 pm will be considered late. **Owners will be charged a late fee off \$1.00 per minute.** **Day Care hours are 7:30am to 5:30pm.** Hospital closes at **5:30 pm**. If your pet has not been picked up by 6:00 pm, your pet will be provided with overnight care also at Owners expense. Any expenses incurred for overnight care, of said pet shall be paid by the Owner in addition to other fees incurred for services provided by at or through Hickory Tree Veterinary Hospital. The hospital is also closed for Lunch (for staff) and Naptime for daycare pets from 12:30 pm to 1:30 pm.

_____ Owner agrees that their pet may be videotaped photographed and/or recorded without notice. Hickory Tree Veterinary Hospital shall be the exclusive owner to the results and all proceeds of such tapings, photography and recordings with the rights throughout the world, an unlimited

Number of times in perpetuity, to copyright, to use and to license to others in any manner. Owner further agrees that their pet may be used in any and all media and in the promotion, advertising, sale, publicizing, and exploitation of Hickory Tree Veterinary Hospital without notice to the owner.
